# **REGISTRATION INFORMATION**

The YMCA offers licensed child care for students when school is not in session, excluding major holidays. Each School Day Out (SDO) Fun Club features a variety of fun, educational and physical activities.

Participants are not required to attend a regular School Age Child Care (SACC) program. However, online KDHE forms must be completed at ymcawichita.org/kdheforms one week prior to attendance, and a registration form must be received three (3) business days prior to attendance and is based on availablity. FULL Payment is required at time of registration, marking days without payment does not enroll student into program. Enrollment is by payment only. Payment is non-refundable, non-transferable.

Space is limited, and registrations are processed in the order received. Register in person at any YMCA location (directors may not accept registrations at SACC or SDO sites).

A minimum of 10 participants is required to provide all-day care. If 10 children do not enroll, parents/guardians will be notified no less than two (2) days prior to day camp.

Late registrations are assessed a \$10 per day late fee. All late registrations must be pre-approved by Jon McReynolds at 264-1610 ext. 8243 and will be based on availability.

NOTICE: All persons authorized to pick up a child must be prepared to show identification (no exceptions).
